

The Marquette County Board of Canvassers met on Thursday, March 1, 2012, at 1:00 p.m. in the County Clerk's Office, Courthouse, 234 W. Baraga Avenue, Marquette, Michigan, to canvass the results of the Presidential Primary Election.

Chairperson Pietro called the meeting to order: Present: Barb Fosmire, Joe Pietro, William Davie, Jon LaSalle and Peter J. Dishnow, Marquette County Clerk. Absent and Excused: Pat Micklow and Fran Baldasari.

It was moved by Barb Fosmire, seconded by Joe Pietro and unanimously carried by voice vote that the minutes of the November 9, 2011 meeting be approved.

Peter J. Dishnow, Clerk, read the Oath of Office to William Davie and Jon LaSalle as they were temporarily appointed to the Marquette County Board of Canvassers, due to the absence of Pat Micklow and Fran Baldasari.

The Board of Canvassers proceeded to canvass the February 28, 2012 Presidential Primary Election as follows:

Shall Humboldt Township levy (Three Mill) renewal for GENERAL OPERATING, and the total rate assessed against all property in Humboldt Township, Marquette County, at a rate of \$3.00 per \$1,000.00 of TAXABLE VALUATION of all property in the Township for a period of five years, 2012 – 2016 inclusive? This millage will generate \$77,298.69 in its first year.
